As a follow-up to the Amnesty International allegations dated 5 January 2017, the CJTF-CIVCAS Cell made the following determinations.

1. Air Strike, 6 April 2016 in Haji Ali: This allegation was originally received on 7 April 2016 and is saved in the tracker as allegation #162. The allegation was subsequently closed due to the lack of corroborating evidence that lends credibility to this allegation. Upon receiving Amnesty's allegation on 5 January 2017, the CITF-OIR CIVCAS Cell reviewed the details contained in the letter, as well as the details in the tracker, to determine whether the allegation needed to be re-opened and tasked out for completion of a CIVCAS Credibility Assessment Report.

After our review, CJTF-OIR CIVCAS Cell determined that the allegation is more likely than not, NOT CREDIBLE, and that the allegation does not need to be re-opened. The nearest strike on 6 April 2016 was strike (b)(1)1.43.33 KM away. Without additional information, there is no evidence lending to the allegation's credibility that Coalition airstrikes were responsible for the destruction and deaths alleged in Amnesty's letter.


2. Air Strike, 23 March 2016 in Haji Ali. This is a new allegation. We officially opened the allegation on 5 February 2017 and closed the allegation 6 March 2017. After our review, CJTF-OIR CIVCAS CELL concluded that it is more likely than not, NOT CREDIBLE. The nearest strike on 23 March 2016 was strike #by111.43.84 KM away. Without additional information, there is no evidence lending to the allegation's credibility that Coalition airstrikes were responsible for the destruction and deaths alleged in Amnesty's letter.
