Rudaw TV meanwhile reported that ten civilians were killed, including a mother and her four kids in the exchange of shelling. @othmanmhmmadr named on of the dead ir Mosul as Dr. Safwan Imad, who was identified as a professor of electrical engineering at the University of Mosul. The report blamed Coalition raids for his death.
