

| (b)(1) tenducted a credibility assessment of possible CIVCAS during 7 K/S conducted IVO of Manbij, Syria between 17-19 June 2016. All reference photos below text.  |
| Background: On 17-19 June 16, The strikes were conducted in support of SDF movement and clearance of Manbij, SY. These strikes were conducted in self-defense of partnered forces, IAW CENTCOM ROE  (b)(1)1.4a  Although the strikes were viewed via ISR, no recorded FMV of the strikes is available at The strike since strikes occurred.   |

| Assessment: Review of (b)(1)1.4c pre and post-strike photos show what is likely the destruction of six structures (Photos 4, 5, 6, 9, 10). Review of pre and post-strike (b)(1)1.4c of the CIVCAS location provided by Human Right Watch (b)(1)1.4a shows no damage to the structure in before and after images during the 17 – 19 Jun 16 strike window (Photo 2). In addition, the time and location of the alleged CIVCAS does not correlate with any (b)(1) thickes. (b)(1) the daducted seven strikes in self-defense of specially designated personnel IAW CENTCOM RC Authorization Serial 3, RO(b)(1)1.45 O OPN (b)(1)1.4a The only strike by (b)(1)1.4a at around 0800 hours during the relevant period shows the destruction of a single structure in open terrain, 1.6 miles south of the location provided by Human Rights Watch. (b)(1)1.4ccsses T(b)(1)1.4dclowed standard operating procedures when prosecuting these strikes, proper collateral scans were conducted prior to rifle, and the area was free of civilians at the time of the strikes. Based on a review of the information, (b)(1) pages sees the allegation of CIVCAS is not credible. |
| Recommendation: Based on the investigative steps already taken, I do not recommend a 15-6 investigation be  |

opened into this strike. **Thirth** allowed standard operating procedures when prosecuting these strikes, and it does not appear that a 15-6 investigation would yield any additional information. Recommend this strike be closed out with CJTF-OIR, deemed not credible. SJA concurs with this recommendation.
