Allegation	January 30th 2017: Al Tabaqa – Raqqa, Ar Raqqah governorate, Syria Summary: Up to three civilians were killed in reported Coalition airstrikes around al Tabaqa when a school was hit in airstrikes. One of the casualtiies was said to be a special needs person.  According to Smart News, "A local source said the [Coalition] planes bombed the area of the villas and Muhammad Al Fares school in Al Thaleth [the third] neighbourhood in al Tabaqa. A medical source explained that two dead and three wounded civilians were brought to the national hospital in Tabaqa – one of them someone with special needs." Syrian Mirror said some of those injured were in a critical condition.  Syria News Desk – which said two civilians died and four were injured, noted that the airstrike "also led to the complete destruction of two houses and material damage to a number of shops and other property."  One of the victims was named by a number of sources as a young man originally from Deir Ezzor province, Omar Faress al Hamir.
